- All electricians are required to adhere to the regulations in accordance to the Singapore Standards CP5.
- A licenced electrical worker is required to be on-site during all power turn on appointments. For technical specifications, see **Technical Guide [Venue]**.
- In addition to the appointment fee, connection point and consumption charges are applicable. Please refer to your licence agreement for rates.
- All wiring is to be set within trench pits (where provided). Between trench pits or where pits are not available, wiring is to be set on top of carpet (where applicable) and placed within wiring trays and must be clearly marked with tiger tape.
- When removing trench pit covers, contractors should ensure that clear signage is placed to denote the potential trip hazard and provide a cover for trenches once the installation work is completed.
- Wiring should not block doors or access points to decoys.
- Upon submission of this form, Suntec Singapore will issue a contract for appointment charges.
- Invoices for appointment charges will be issued upon receipt of signed contract. Invoices for connection and consumption charges will follow after the event.
- Pre-payment is required for all appointment charges.
- Suntec Singapore reserves the right to revise the indicative prices and service offerings without prior notice given.
